Projects to be completed will be the creation of an informational video to be recorded on DVD in large enough quantities that they can be given away to the public and specific information targeting trucking companies that haul hazardous materials in this area. The video will have information on proper oil disposal practices and other local recycling opportunities, chemical safety in the home and at work, and poison control tips. The

information for the trucking companies will include a packet with bulletin board quality posters and reading materials with most frequently asked questions, local ordinance information, and contact information for the LEPC. The motion was seconded and carried.
