The meeting was called to order by Kevin Starbuck, LEPC Chairman.

- Item 6:** Changes to the current by-laws and Final Rules were presented. Judith made a motion to accept the changes as presented. The motion was seconded and passed. Committee assignments were reviewed and a signup sheet passed around.
